

**TREASURED ADVENTURES FLORIDA, LLC  
TREASURE HUNT TERMS AND CONDITIONS**

1. Activity Period. This Treasure Hunt (the "Activity") begins on November 21, 2020, 8:00 AM and will close when the first Participant successfully navigates the maps, clues and challenges provided, and finds the “treasure”.
